#### **The Client Support Fund**

September was back-to-school season, a time that should be filled with excitement and possibility. Last month, as our clients prepared to return to school, we shared how challenging this time of year can be for many of the young people we serve. The cost of new clothes, school supplies, reliable transportation, and even basic technology can quickly become overwhelming. That's why we created the **Client Support Fund**, to ensure no student's education is disrupted because they lack the essentials needed to learn and thrive.

Thanks to your generosity after this appeal, this Fund made a real difference for our clients this fall and will continue to do so. One student received safe, reliable rides to school until the bus system started running, ensuring they didn't miss a single day of class. The Fund also recently provided a laptop for a hardworking student determined to complete their final high school credits. Following the client's release, their EdLaw team collaborated with the local school district to create a pathway for completing the final five credits needed to graduate by the end of the year. Based on their circumstances (age and recently released from the house of corrections) they were not eligible to receive a laptop through other programs that typically provide electronics to students. The fund stepped in to ensure they had the technology needed to stay on track and meet their academic goals. With the support of the Client Support Fund, the client is now on track to finish their remaining coursework—all while maintaining full-time employment—and is moving confidently toward earning their high school diploma.

These are just two examples of how your support fueled opportunity, stability, and hope for our clients during the critical back-to-school season.

From all of us at the **Youth Advocacy Foundation**, thank you for standing with us and for believing in the potential of every young person we serve.



If we haven't seen or heard from you in a while, we warmly invite you to attend, support, or sponsor the event and celebrate alongside our community of friends, advocates, and partners.



# Exciting Update! State Department of Elementary and Secondary Education Approves New Regulations about the Use of Seclusion and Time-out

In our last newsletter, we reported that DESE was considering these changes and we're happy to announce that in July, they approved new regulations that clarify and update how these practices can be used and ensure stronger protections for students.

- Time-out must now happen in spaces that are unlocked and allow students to leave freely. Seclusion is only allowed in emergencies involving an imminent risk of serious physical harm—and even then, only with strict safeguards in place.
- Schools will need to make sure any room used for time-out meets specific standards: it must be age-appropriate, safe, ventilated, and meet building and fire codes.
- Emergency seclusion will now require adult supervision, parental consent, and documentation from a licensed physician or mental health professional, along with clear communication to families and regular data reporting to DESE.



These updates will go into effect August 17, 2026, giving districts time to prepare and implement changes. These steps are intended that time-out and seclusion are used safely, appropriately, and only when absolutely necessary—with transparency and student well-being at the center. ### The Protect Education Equity Bill PASSED!

EdLaw attorneys, in partnership with Massachusetts Advocates for Children (MAC), co-wrote a critical brief to the Education Committee detailing the legislative history of *manifestation determinations* in Massachusetts law helping to secure stronger protections for students with disabilities in the new Protect Education Equity Bill.

This is a major win for immigrant students and students with disabilities across the Commonwealth and a critical step in safeguarding education rights under threat at the federal level.

#### The new law:

- Protects students of all immigration statuses
- Ensures *trained interpreters* for families
- Safeguards *special education services* for English learners with disabilities
- Prevents *discriminatory discipline* of students with disabilities



Shortly after passing the Massachusetts legislature it was signed into law by Governer Maura Healey. Massachusetts law now clearly states, something that was always true, that every kid has the right to go to school without being discriminated against because of their immigration status or disability.

This law is a big deal! To summarize, it means students with disabilities are protected from unfair discipline, families must get trained interpreters when needed, special ed teams have to understand the needs of English learners, and schools can't push families to give up supports just to make the schedule work.

This happened because families spoke up, advocates pushed hard, and lawmakers stepped up. And now our state is setting an important example, even when things at the federal level feel shaky.

Huge thanks and congrats to everyone who made this happen. This win was made possible by the tireless work of advocates, families, and legislative champions across the state. We're proud to be part of the fight to protect education equity for *every* student in Massachusetts. Now we get to work making sure the law is put into action.

## Where Do Students and Families Stand with the Threatened Closure of the US Department of Education

In July, a Senate report from Senator Warren's office was released detailing major changes to the U.S. Department of Education under the Trump administration, highlighting cuts to student aid, civil rights enforcement, and federal education data systems.

#### Key takeaways:

- Reduced access to federal student loans and grant programs
- Major staffing cuts at the Office for Civil Rights, limiting response to discrimination in schools
- Sharp reductions in national education data collection and research
- Proposals to transfer core education responsibilities to other federal agencies

According to the report, these actions could have long-term consequences for millions of students—particularly those from low-income backgrounds, students of color, and students with disabilities.

What to Read this Week...
